Technical characteristics

ECOPROTETTIVO FERRO by OIKOS is a 100% acrylic, transparent, protective coating for metal. It is non-yellowing, scratch resistant, water repellent and washable, unalterable over time. Protecting the metal, the product brings out and highlights the beauty and the decorative patterns of the support, with a gloss effect. The product has a decorative function, not an anticorrosive one. It is ideal to protect ECOSMALTO FERROMICACEO by OIKOS from wear and dirt. The product has a low odour level, is non-inflammable and friendly to both humans and the environment.

Ideal use

Protection for ECOSMALTO FERROMICACEO by OIKOS

Surface preparation

Clean the surface to be treated, removing any dirt, dust and grease with the appropriate products

Application method

Apply one or two coats of ECOPROTETTIVO FERRO not diluted by brush or roller leaving 6 hours between coats. Dilute ECOPROTETTIVO FERRO 5 ÷ 10% with drinkable water for application by spray gun (0.8 ÷ 1.3 mm nozzle)
